9	6 January 1913	G. M. Berry, Secretary, Syracuse Section of the American Chemical Society, Syracuse, NY to C. P. Steinmetz. Invitation to speak on "Atmospheric Nitrogen."
10	7 January 1913	N. C. Miller, General Electric Company, St. Peterboro, Ontario to Schenectady Branch American Institute of Electrical Engineers. Notification of a new engineering society, called the Technical Society, being formed in St. Peterboro. The new society requests that the Schenectady A. I. E. E. send a prestigious member (Dr. Steinmetz, preferred) to lecture to the new group. A lecture of this type would be the "FIRST EVER HELD IN PETERBORO."

13	7 January 1913	H. C. Senior to C. B. Jacobs, American Abrasive Metals, Co., NY, NY. Referencing a letter of 28 December 1912 (Book 14, 271), Dr. Steinmetz "...would be glad to have you use his name as reference..."
14	7 January 1913	H. C. Senior to S. W. Smith, The Electrical Association, Province of Quebec, Montreal. Referencing the letter of 3 January 1913 (8 above), Dr. Steinmetz "...very much regrets that he will be unable to accept the invitation..."
15	7 January 1913	H. G. Stott, Superintendent Motive Power, Interborough Rapid Transit Company, NY, NY to C. P. Steinmetz. Invitation to "...an informal dinner of engineers..." on 29 January 1913, and to speak at the event "...on the question of Power Development of the Future.".
16	9 January 1913	F. F. Fowle, Associate Editor, Electrical World, NY, NY to C. P. Steinmetz. Letter chastising Dr. Steinmetz for his failure to provide a review of "lightning phenomena and their control."
17	9 January 1913	C. P. Steinmetz to C. A. Coffin, President, General Electric Company, NY, NY. Notification of the proposed changes to the Engineering Course at Union College. Dr. Steinmetz states that "...organizing the under graduate and graduate course as a feeder to our Company...but with the limited time available to me, I can not do it..." Dr. Richmond, President of Union College and Dr. Steinmetz request that "...Dr. E. J. Berg (be induced) to accept the Professorship at Union College..."
18	9 January 1913	C. P. Steinmetz to C. A. Coffin, President, General Electric Company, NY, NY. Same as above.
19	9 January 1913	C. P. Steinmetz to G. R. Lunn, Mayor, City of Schenectady. Letter accompanying the "...preliminary draft of a report on the school system..." <i>Draft not included.</i>
20	10 January 1913	Committee on Housing, Schenectady, NY to C. P. Steinmetz. Invitation to join "...the Citizen's Committee of Fifty described in the attached clipping," with directions on what to do if interested.
20a	10 January 1913	Committee on Housing, Schenectady, NY to C. P. Steinmetz. Handwritten note stating, "I gave (A. W.) Clark permission to use your name as I knew you were in sympathy with it."
20b	10 January 1913	Committee on Housing, Schenectady, NY to C. P. Steinmetz. Newspaper clipping about the Committee of Fifty, noting Dr. Steinmetz as already being a member.

29	15 January 1913	H. C. Senior to H. G. Stott, Interborough Rapid Transit, Co., NY, NY. Referencing the letter of 7 January 1913 (15 above), Dr. Steinmetz will be "...unable to be with you at this time..."

Request for schedule of meetings and a topic on which Dr. Steinmetz should speak.
41	27 January 1913	E. J. Berg, University of Illinois, Urbana, IL to C. P. Steinmetz. Referencing the letter of 20 January 1913 (see 32 above), Magnusson is coming for an interview. Dean Goss (of UC, Urbana) would prefer the search is concluded before Union College announces Dr. Berg as a member of their community. Additionally, he spoke with Dr. Richmond last week in Detroit, who noted that Dr. Steinmetz could take whatever title he wished. Dr. Berg noted professor of electrodynamics as a good choice. Dr. Berg closed by stating that he would be in Schenectady over Easter and looks forward to an opportunity "...to talk over several things that have occurred to me lately."

E. faculty, that is when and how many classes and laboratory periods each man has."
