Banks 1	n.d.	Mohawk Bank, 216 State Street. Chartered as a State bank in 1807; National bank in 1856: m. Facsimile of the first directors' meeting of the bank. See also Misc 429.

Banks 4	19 Aug 1806	Charter of New York Bank issued by the state secretary's office; passed by the assembly 14 Mar 1803; bill having been read for the third time.
