<u>Abstract</u>: The collection comprises the records of the Townsend Club of Schenectady, including meeting minutes, notes, and treasurer's records.

Scope and Content Note:

The collection comprises the records of the Townsend Club of Schenectady, including meeting minutes, notes, and treasurer's records. The collection is composed of ledgers for the period 1937-1943.

Organization History:

In 1933, Dr. Francis E. Townsend wrote a letter to a California newspaper advocating the establishment of a government-sponsored old age pension plan. The response was immediate and overwhelmingly favorable. This led to the establishment of "Townsend Clubs" all across the country and eventually to the Social Security Act of 1937.

The home office was located in Chicago, Illinois. All chapters were assigned a number, Schenectady being No. 1. There was both male and female membership. The club met at 6 Mynderse Street in Schenectady. The Ladies Auxiliary Committee formed November 1943, composed from the various clubs of Schenectady.

Officer/council elections were held yearly. Officers elected in 1940 were: Mr. Berical (President); Mr. Shafer (First Vice President); Mrs. Stophilbeen (Second Vice President); Mrs. Sellick (Secretary); Mrs. Warner (Treasurer); Mrs. Lawyer (Membership); Mr. Passage (Publicity and Extension); Mrs. Schlansker (Social); Mrs. Adams (Program); Mrs. Berical (Public Relations); Mrs. Hopensitz (Ladies Auxiliary); Mr. Hicks (Finance).
